CODE OF CONDUCT 2022-2023

This Code of Conduct identifies the standard of behavior, which is expected of all GBLBL (Grey Bruce Ladies Broomball League) members, and participants, which includes players and coaches.

GBLBL is committed to providing an environment in which all individuals are treated with respect. Members and participants of GBLBL shall conduct themselves at all times in a manner consistent with the values of GBLBL, which includes fairness, integrity and mutual respect.

Members and participants of GBLBL shall refrain from comments or behaviors, which are disrespectful, offensive, abusive, racist or sexist. In particular, behavior, which constitutes harassment or abuse, will not be tolerated, and will be dealt with accordingly.

Failure to comply with this Code of Conduct may result in disciplinary action. Such action may result in the member and participant losing the privileges, which come with GBLBL, including the opportunity to participate in GBLBL activities and events, both present and future.

Due to increasing violence and verbal abuse that was seen in the league, more strict rules were added in February 2010 and have since been revised in March 2011 by the Disciplinary Committee. These revised rules are now found in the Disciplinary Committee Letter which covers checking from behind, fighting, unsportsmanlike/misconduct penalties, and any other major penalties.

Abuse, whether it is directed towards another player, ref, or fans will not be tolerated. Immediate penalties will result. Anyone who continues the verbal abuse will be ejected from the game. If someone is ejected from the game a notification will be sent to the disciplinary committee. If the individual has another verbal abuse penalty in the same season, the disciplinary committee will decide on the appropriate suspension.

There is a Disciplinary Committee that will handle all issues that exceed or are outside the guidelines of the written Disciplinary Committee letter.
